

THE "WIX PHOTOGRAPHY" CONTEST RULES (the "Rules")

- **NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.**
- **THIS PROMOTION IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH ANY SOCIAL NETWORK PLATFORM.**
- **THIS IS A SKILL-BASED CONTEST.**

Important: Please read these rules before entering this Contest. By participating in this Contest, you agree to be bound by these Rules.

1. SPONSOR

The Contest is sponsored and held by Wix.com, Ltd. (with its worldwide affiliated companies - "**Wix**" or "**Sponsor**"), having its principal offices at 40 Namal Tel Aviv Street, Tel Aviv, Israel. This Contest is in no way sponsored, endorsed or administered by, or associated with Twitter, Facebook, Instagram or any other social media platform.

2. ELIGIBILITY

The Wix Photography Contest (the "**Contest**") is open only to persons ("**Participant/s**") who (i) are legal residents and are physically located and reside in a jurisdiction in which this type of contest is permitted, and (ii) have reached the age of majority in their jurisdiction of residence at the time of entry, and (iii) who hold a website created on the [Wix platform](#) and conforms to Wix's [Privacy Policy](#) and [Terms of Use](#) (the "**Wix Portfolio**"), and (iv) the Wix Portfolio includes only photographs created by Participant and to which Participant owns all rights and title. Employees of Sponsor, Vanity Fair ("**VF**"), Conde Nast Traveler ("**CNT**") and Brides Magazine ("**Brides**") (collectively referred to as the "**Magazines**"), and their respective parent, affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers, directors, officers, and each of their immediate family members and/or those living in the same household of each are not eligible to enter the Contest.

3. ENTRY PERIOD

Entries can be submitted from 10 A.M. GMT July 26, 2016, until 11 P.M. GMT August 9, 2016 (the "**Entry Period**").

4. HOW TO ENTER

- 4.1. These Contest Rules will be available on the official Wix Photography Contest page which can be found here: www.Wix.com/LookStunning (the "**Contest Website**").
- 4.2. The Contest is targeted to determine the most successful Wix Portfolio, as per the judgement criteria specified in section 5.2 below.
- 4.3. To participate in the Contest, you must submit your entry, during the Entry Period, as follows:
 - a) Sign up on the Contest Website by logging into your Wix Portfolio (using your email and password).
 - b) Fill in a submission form available on the Contest Website by completing the following details: (i) Name; (ii) Email; (iii) Phone number; (iv) Country of residence; (v) Wix Portfolio URL; (vi) your one Magazine choice (only one of VF/CNT/Brides)

(“**Entrant’s Magazine Choice**”) and any other detail which may be required by Sponsor in the submission process.

You may, at your discretion, add a short paragraph describing you, your work, your inspiration or any other input relating to your love for photography.

- c) To complete your submission you must agree to these Rules and submit your entry by pressing the ‘Submit’ button.
- 4.4. Upon successfully completing a submission in accordance with the foregoing requirements and these Rules, you shall be considered as submitting an entry into the Contest (“**Entry**” or “**Entries**”). Sponsor has no obligation to advise an entrant of an incomplete or otherwise non-compliant Entry. Proof of submitting an Entry will not be deemed to be proof of receipt by Sponsor.
- 4.5. All Entries must be submitted and received by the Sponsor within the Entry Period and comply with all other requirements set forth in these Rules.
- 4.6. Entries will be deemed to be made by the authorized holder of the Wix Portfolio website submitting the Entry, at the time of Entry. In the event of a dispute, the potential winner may be required to provide proof that he or she is the authorized holder of the identified Wix Portfolio account. Once an Entry is submitted by a Participant by clicking the "submit" button, the personal details submitted in the Entry form cannot be revised. However, Participants may update their Wix Portfolio website throughout the Entry Period.
- 4.7. Sponsor may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) promotion does not constitute entry into any other.
- 4.8. Each Participant may submit more than one (1) Entry, but not more than three (3) Entries, provided each Entry refers to a different Wix Portfolio. However, each Participant may win only one prize, even if he/she submits multiple Entries.
- 4.9. Entries must not contain content that: (i) is sexually explicit, violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; (ii) promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing) or a particular political agenda; (iii) is obscene or offensive; (iv) defames, misrepresents or contains disparaging remarks about other people or companies; (v) contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others without the proper license or consent; (vi) violate the rights of any other person or entity by using their names or images, or featuring or referring to any recognizable person, without such person’s informed consent thereto; (vii) violates copyrighted materials owned by others (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media); and/or (viii) violates any law or any legal terms applicable to such Entry, including the terms of use of any social platform media in which the Participant chooses to share his/her Wix Portfolio.
- 4.10. You are not required to “like” or follow Wix on any social network platform or to place any purchase with Wix or pay any fee in order to participate in the Contest or be eligible for a Prize, and any such action, purchase or payment will not increase or improve your chances of winning.
- 4.11. The Sponsor reserves the right to amend these Rules at any time.

- 4.12. SPONSOR RESERVES THE RIGHT TO DISQUALIFY FROM THE CONTEST ANY ENTRY WHICH DOES NOT COMPLY WITH THESE RULES, OR FOR ANY OTHER REASON, AS SPONSOR DEEMS FIT, AT SPONSOR'S SOLE AND ABSOLUTE DISCRETION.

5. DETERMINING THE WINNERS

- 5.1. The Contest shall have up to three (3) winners (each, a "**Winner**", and collectively the "**Winners**") who will each be awarded one of the prizes set forth in Section 6 below by the respective Magazine (the "**Prize/s**").
- 5.2. The Winner of each Prize shall be selected by one or more judges representing the respective Magazine awarding such Prize. Entries shall be judged based on the quality (33%), creativity and originality (33%), structure and layout of the Wix Portfolio (34%) as determined by the respective judges at their sole and full discretion.
- 5.3. Each Entry shall be judged only by such judge(s) that corresponds to the Entrant's Magazine Choice in the respective Entry form and shall be eligible to win only the Prize awarded by such Magazine, unless determined otherwise at Sponsor's full discretion.
- 5.4. Sponsor reserves the right to issue fewer Prizes if there are insufficient valid Entries that meet the criteria or comply with these Rules. Sponsor also reserves the right to award more Prizes, for instance, if there are ties.
- 5.5. Maximum one (1) Prize per Participant.

6. PRIZES

- 6.1. Each of the Magazines will award the respective Winners the following Prizes:
- 6.1.1. One of the below, as applicable:
- VF: Assisting on a Vanity Fair cover shoot alongside editors and creative directors, plus \$1,000 cash prize.
 - CNT: Shooting a future issue cover of "Conde Nast Traveler" magazine in cooperation with the editors and creative directors of the Magazine, plus \$1,000 cash prize.
 - Brides: Shooting a future issue cover of "Brides" magazine in cooperation with the editors and creative directors of the Magazine, plus \$1,000 cash prize.
- 6.1.2. The right to participate in a behind-the-scenes video featuring the Winner's experience on the set.
- 6.1.3. A 1/3 page spread in the respective Magazine, describing the Winner's story and their work, as well as relevant credit in the "contributors page".
- 6.2. The Prizes are granted by each respective Magazine and not by the Sponsor. Sponsor does not undertake any responsibility for the actual grant of the Prize and the execution and/or publication of any cover shoot and/or the other Prize components. However, the Magazines are not sponsors of this Contest and are not otherwise responsible for its administration or fulfillment.

Each cover shoot will be scheduled by the respective Magazine; if a Winner cannot participate at that time that portion of the prize will be forfeited and an alternate winner may be selected. Each cover shoot will be under the direction of the Creative Director of each Magazine.

- 6.3. Each Magazine will be the copyright owner of all the photographs produced at its cover shoot and each Winner will be required to sign an agreement acknowledging that the photographs are created on a “work-made-for-hire/all rights” basis and that the Magazine has the right to edit, crop or otherwise modify all photographs.
- 6.4. Sponsor will provide flight tickets and accommodation for the actual Winners, for the duration of the respective cover shoot. Scope and nature of travel and accommodation shall be decided solely by Sponsor. Winners shall be responsible for obtaining any relevant documentation, visas, travel passes etc. in connection with the travel to the destination of the cover shoot if applicable.
- 6.5. Prizes are non-transferable, with no additional cash redemptions, equivalents or substitutions except at Sponsor’s and/or Magazine’s sole and absolute discretion. All Prize details not specified in these Rules, including timelines, will be determined in Sponsor’s and/or the respective Magazine’s sole and absolute discretion, and are subject to change.
- 6.6. All Prizes are awarded “AS IS” and without warranty of any kind, express or implied. Sponsor does not endorse any privacy policies or terms of service, licenses or warranties for any of the Prizes.
- 6.7. The Winners will be solely responsible for all federal, state and/or local taxes according to the laws and regulations applicable in such Winner’s residence, and for any other fees, costs and other arrangements associated with the Prize(s) which are not explicitly provided by Sponsor and/or the Magazines as set forth herein. A Winner may be required to provide Sponsor and/or Magazine with a valid social security number, tax identification number or any other identification details, before the Prize will be awarded for tax reporting purposes. An IRS Form 1099 or equivalent may be issued in the name of Winner for the actual value of the Prize received. A Winner may further be required to provide Sponsor and/or the respective Magazine with additional details relating to the Wix Portfolio, his personal details, his professional experience and other details as shall be requested by the respective Magazine.
- 6.8. Unclaimed Prizes will be forfeited. Without derogating from the generality of the above, any failure by a Participant to claim and collect the Prize, including without limitation due to the schedule and timelines of the Prize determined by Sponsor/Magazines, the failure of Sponsor and/or the Magazines to reach the Winner in order to coordinate the Prize details, the failure of the Winner to obtain the appropriate travel documents, to execute any document requested by Sponsor/Magazines or to otherwise cooperate with Sponsor, or for any other reason whatsoever at Sponsor’s reasonable discretion, shall not result in any liability to the Sponsor and the Magazines. Furthermore, Sponsor and the Magazines reserve the right to refuse to provide the Prize to the said Winner and to offer the Prize to the runner-up Participant in such cases.
- 6.9. Sponsor and/or the Magazines may conduct a background check to confirm any potential winner’s eligibility and compliance with these rules. By entering, you agree to cooperate reasonably with any such background check. If a background check reveals that a potential winner has engaged in conduct that could damage the reputation or business of Sponsor Entity

or a Magazine, as determined by Sponsor or Magazine in its discretion, the potential winner may be disqualified and the prize may be awarded to an alternate winner.

7. **WINNER NOTIFICATION AND PRIZE CLAIMING**

- 7.1. Between 8:00 A.M. GMT on August 10 and 6:00 P.M. GMT on August 24, 2016, the judge(s) from each Magazine will review all the relevant Entries (*i.e.* such entries in which such Magazine has been indicated as the Entrant's Magazine Choice) received within the Entry Period and select the respective Winner ("**Judgment Period**"). For the avoidance of doubt, Sponsor and/or any of the Magazines cannot guarantee the exact time during the Judgment Period in which each Entry will be reviewed, hence any modifications made by a Participant to his/her Wix Portfolio during the Judgment Period but after the review by the judges, will not be reviewed.
- 7.2. Sponsor will announce the potential Winners to the public on August 25, 2016, including on Wix's official social media accounts and other public relations channels, and will notify the potential Winners via e-mail (where available) or by any other method as Sponsor sees fit at its discretion. The potential Winner will be required to comply with all further instructions provided by Wix within the timeframe specified. Non-compliance within any indicated time period may result in disqualification and an alternate potential Winner will be selected. Wix assumes no responsibility for undeliverable notifications for any reason whatsoever and the return of any notification as undeliverable will result in disqualification of the Entry and an alternate potential Winner may be selected.
- 7.3. Sponsor has complete discretion over interpretation of the Rules and administration of the Contest. Selection of Winners is at the complete discretion of the respective Magazine judges. Decisions of the selection of a Winner will be final.
- 7.4. Each potential Winner may be required to submit an affidavit of eligibility / release of liability / prize acceptance agreement (the "**Prize Acceptance Agreement**"), and return same within the time period specified at notification before being eligible to receive his or her Prize. If any of the potential Winners fails to timely submit a Prize Acceptance Agreement, their Entry may be disqualified at Sponsor's sole discretion.

8. **PRIVACY AND CONTEST COMMUNICATIONS**

- 8.1. Except as specifically stated herein, your participation and the personal information collected from Participants during the Contest are subject to Sponsor's [Privacy Policy](#) and [Terms of Use](#). You undertake to comply with any and all applicable federal, state and local laws, rules and regulations.
- 8.2. By entering this Contest, you understand that Sponsor, the Magazines, their respective third party vendors, and their advertising or promotion agencies may use your personal information (including email address) for administration of the Contest, the fulfillment of Prizes, for marketing purposes and to provide you with information about Sponsor's and Magazines' programs, products, services and special offers. You expressly consent to the use of your information by Sponsor and the Magazines and their advertising or promotion agencies for such purposes.

9. **ENTRY LICENSE AND PUBLICITY RELEASE**

- 9.1. By submitting your Entry to the Contest, you acknowledge and agree to the following:
- 9.1.1. The review and evaluation process of the Entries by the judges may be recorded, filmed and edited by any of the Authorized Parties (“**Judgment Materials**”).
 - 9.1.2. Winners of the Contest will post links and posts on social media platforms, as shall be required by any of the Authorized Parties (defined below), in connection with the Contest and may be filmed, recorded interviewed and/or photographed by any of the Authorized Parties, before, during and/or after the receipt of the Prize and the cover shoot (“**Winners’ Materials**”). For the avoidance of doubt, all rights, title and interests, including copyrights and other intellectual property rights, throughout the world, in and to the Judgment Materials and Winners' Materials in all formats, are and shall be exclusively owned by the respective Authorized Party.
 - 9.1.3. Authorized Parties may use your name, username, photograph, voice, any other likeness, Entry details and any other communications or comments related to the Contest (“**Likeness**”).
 - 9.1.4. Sponsor may feature your Entry on the Contest Website, in a position/location determined at Sponsor’s sole discretion if applicable, using a ‘cover image’ (screen shot of your Wix Portfolio or other cover image as determined by Sponsor) created by Sponsor. Viewers of the Contest Website shall have the right to view the Cover image of each Entry and endorse any cover image they choose by clicking on the “love” button (the “**Endorsements**”). Sponsor shall have the right to display the number of Endorsements each Entry receives and to rate the Entries pursuant to the number of endorsements or pursuant to any other criteria as decided by the sole discretion of Sponsor.
- 9.2. By participating in the Contest, you grant Wix, each of the Magazines, and their respective shareholders and licensees (“**Authorized Parties**”) an irrevocable, perpetual, worldwide non-exclusive, royalty-free license to reproduce, distribute, display and create derivative works of your Entry and Wix Portfolio (or any part thereof, including your photographs featured therein) in connection with the Contest and the promotion of the Contest, in any media now or hereafter known, including, but not limited to: (i) publications in print and/or online by any of the Magazines, featuring select Entries in the Contest and/or the Winners; (ii) publication on www.wix.com or via any other media or platform (iii) display of photographs included in your Wix Portfolio (or any other detail in the Wix Portfolio) and your details on the Contest Website, the Magazine websites and via social media channels of the Sponsor and/or the Magazines. The foregoing license is only in addition to and shall not derogate from any other license you grant Sponsor with respect to your Wix Portfolio (such as the limited license granted under the Terms of Use).
- 9.3. For the avoidance of doubt, none of the Authorized Parties shall be under any obligation to promote or publish your Entry or your Wix Portfolio in any way, all of which shall remain at their full discretion;
- 9.4. Any display or publication of any Entry on an Authorized Party’s website or on any other channels does not indicate in any way that the Participant will be selected as a Winner or has

better chances to be selected as a Winner and Authorized Parties will not be required to pay any additional consideration or seek any additional approval in connection with such use.

- 9.5. You hereby consent to Sponsor and Magazines doing or omitting to do any act that would otherwise infringe your moral rights, privacy rights or publicity rights in your Entry, your Wix Portfolio or any materials featured therein, or in any other material produced in the framework of the Contest, including but without limitation, the Judgment Materials, the Winner's Materials and the use of any Likeness, and to the fullest extent permitted by law you waive such rights.
- 9.6. Upon Sponsor's request, each Participant must be prepared to provide (within seven (7) calendar days of receipt of Sponsor's request) a signed license agreement authorizing the Authorized Parties to reproduce, distribute, display, and create derivative works of the Entry (or part thereof) in connection with the Contest and promotion of the Contest, in any media now or hereafter known. All license agreements must be in the form provided by Sponsor or satisfactory to Sponsor. Failure to provide such license agreement upon request may result in disqualification at any time during the Contest and selection of an alternate Winner.

10. INTELLECTUAL PROPERTY

The Contest Rules, the Contest, and all related web pages, content and code are the property of the Sponsor or authorized third parties. The copying or use of any of those materials, associated trademarks or any other intellectual property without the express written consent of its owner is strictly prohibited.

11. RELEASE

- 11.1. By participating in the Contest, you agree to release Sponsor, each of the Magazines and all of their respective parent, subsidiaries, affiliates, agents, distributors, licensors, licensees, representatives, attorneys, prize providers, advertising and promotion agencies, and each of their respective directors, officers, employees, agents, successors and assigns ("**Released Parties**"), from any claims, liability, costs, losses, damages or injuries of any kind arising out of or related directly or indirectly to your participation in the Contest, including with respect to any deletion or failure to store any Entries and other communications related to the Contest.
- 11.2. You agree that the Released Parties: (i) have neither made nor will be responsible for any warranty, express or implied, in connection with the Contest (including Prizes); (ii) and will not be responsible or liable for any injury that may be caused by the wrongful act of any other person or entity, including Contest Participants, and by any cause whatsoever beyond the control of the Released Parties.
- 11.3. You further understand and agree that all rights under Section 1542 of the Civil Code of California ("Section 1542") and any similar law of any state, province or territory of the United States or of Canada that may be applicable are hereby expressly and forever waived. You acknowledge that Section 1542 provides that: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH, IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."
- 11.4. Upon Sponsor's request, each participant must be prepared to provide (within seven (7) calendar days of receipt of Sponsor's request) a signed release or consent form from any person

who appears, and/or owner of any property featured in certain photographs displayed on your Wix Portfolio as requested by the Sponsor and/or the Magazines , and/or from the owner of any material that appears in such specific photograph, authorizing the Authorized Parties to use such photos as stipulated herein. All releases must be in the form provided by Sponsor or satisfactory to Sponsor. Failure to provide such releases upon request may result in disqualification at any time during the Contest and selection of an alternate Winner. For the avoidance of doubt, Sponsor's request to receive releases as aforesaid, or its failure to request the same, shall not (i) constitute a waiver of Sponsor's rights or your undertakings under the Rules or (ii) imply a representation or belief that your Entry complies with the Rules or any applicable Laws.

12. YOUR REPRESENTATIONS, WARRANTIES AND INDEMNITY

By submitting an Entry into the Contest you represent, warrant, undertake and agree that:

- 12.1. You have read, understand and will follow these Rules.
- 12.2. You have the right and the legal standing to agree to and be bound by these Rules and to register to the Contest.
- 12.3. You agree to indemnify and hold the Released Parties harmless from any third party claims arising out of or related in any way, directly or indirectly, to your participation in the Contest or acceptance or use of any Prize.
- 12.4. You are solely responsible for your Wix Portfolio and the photographs presented therein and the consequences of Sponsor and/or Magazines using or publishing such photographs as stipulated herein.
- 12.5. The photographs on your Wix Portfolio were taken by you and you own all rights and title, or otherwise have (and will continue to have) the full power, title, licenses, consents and authority, as necessary to participate in the Contest, to comply with the Rules and enable Sponsor and/or the Magazines to use them as indicated in these Rules.
- 12.6. The photographs in your Wix Portfolio do not and will not infringe the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity.
- 12.7. The Entry does not violate the Rules or any applicable law, and does not contain any content which is unlawful for you to possess, post or disseminate in the country in which you reside, or which would be unlawful for Sponsor to use or possess in connection with the Contest, or which violates any contractual or fiduciary rights, duties, or agreements by which you are bound;

13. SUSPENSION / MODIFICATION / TERMINATION

- 13.1. If Sponsor is prevented from continuing with the Contest by any event or cause beyond its control, e.g., events of nature, interference by humans, non-humans or entities unrelated to Sponsor (including but not limited to DDoS attacks, bot/script attacks, or heavy volume use that crashes or severely hinders access to the Contest), acts of government (each a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Contest.

- 13.2. Additionally, Sponsor shall have the right to suspend, modify or terminate the Contest for any reason at its sole discretion.
- 13.3. If the Contest is terminated, the Sponsor, at its sole discretion, may select the potential Winners from all eligible Entries received prior to termination.

14. TAMPERING

Sponsor will disqualify any individual that attempts to tamper with or undermine the legitimate operation of the Contest and reserves the right to seek damages (including attorneys' fees) and other remedies from any such individual to the fullest extent permitted by law.

15. GOVERNING LAW / LIMITATION OF LIABILITY

- 15.1. All issues concerning the Contest and these Rules shall be governed by New York law, without giving effect to any choice of law or conflict of law rules that would cause the application of any other state's laws.
- 15.2. BY ENTERING THE CONTEST, YOU AGREE THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY CLAIMS WILL BE LIMITED TO ACTUAL THIRD PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (2) UNDER NO CIRCUMSTANCES WILL YOU BE PERMITTED TO OBTAIN ANY AWARD FOR PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (3) YOU IRREVOCABLY WAIVE ANY RIGHT TO SEEK EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.
- 15.3. YOU UNDERSTAND AND AGREE THAT PARTICIPATION IN THIS CONTEST IS AT YOUR OWN DISCRETION AND RISK. YOU UNDERSTAND THAT SPONSOR MAKES NO REPRESENTATIONS OR WARRANTIES REGARDING THE RELIABILITY, TIMELINESS, AVAILABILITY AND/OR PERFORMANCE OF ANY ELEMENT OF THIS CONTEST OR THE PRIZE AWARDS. SPONSOR AND ITS RESPECTIVE PARENTS, SUBSIDIARIES, AFFILIATES, ADVERTISING AND PROMOTIONAL AGENCIES, AND ALL THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, REPRESENTATIVES AND AGENTS DISCLAIM ANY LIABILITY FOR DAMAGE TO ANY COMPUTER SYSTEM OR LOSS OF DATA RESULTING FROM ACCESS TO OR THE DOWNLOAD OF INFORMATION OR MATERIALS CONNECTED WITH THE CONTEST.

16. MANDATORY ARBITRATION / NO CLASS RELIEF
